Our recycling facilities serve EPS end-users, building and road construction sites, as well as other EPS manufacturers. Our granulating machines reduce moulded EPS into beads that are then reformed into new, sustainably produced EPS products.

## Leading by example as an EPISA member

Foamex is a proud, long-serving member of Expanded Polystyrene Australia (EPISA), the peak national body for EPS manufacturers and distributors in Australia. We stringently follow all EPISA recommended EPS distribution and clean-up responsibilities as outlined in the Pod Code of Practice.

## Why correctly disposing of EPS is important

- EPS is used in a wide variety of industries, so there is a lot of it.
- EPS is purpose-moulded for specific use, so it cannot be re-used.
- EPS is bulky in nature, so it occupies a lot of space in landfill.
- Recycled EPS can be used to make new EPS products.

Foamex is partnering with our clients as well as communities to help raise awareness about the correct way to dispose of EPS. EPS shouldn't be put in typical recycling bins. But nor should it be put in general waste bins. The truth is, EPS is recyclable. But recycling EPS requires a specific process and currently it is only recycled in large industrial quantities in Australia.



## What can you do to help?

We support and encourage both our clients and members of the public to recycle their unwanted EPS by returning it (with prior arrangement) to one of our four collection facilities in Australia – Sydney, Melbourne, Brisbane and Adelaide.



## What EPS products CAN be recycled

- Packaging for small & large appliances (i.e.: big screen TV's, dishwashers & oven packaging)
- White polystyrene fruit & vegetable boxes (clean boxes only - all organic material & labels must be removed prior to recycling)
- One car boot load of EPS at a time for household drop-offs
- Uncontaminated (i.e., mud and concrete free) EPS from building & construction sites
- Bean bag beans



## What EPS products CAN'T be recycled

- Coloured polystyrene
- Food packaging
- Peanut-shaped loose foam packaging
- Meat trays
- Tape or strapping
- Plastic or foam wrapping
- Any EPS products that feature paper/plastic labels
- Polystyrene covered in dirt, concrete or cement
